It is ORDERED that effective May 1, 2024, (a) the Court's March 10, 2020 Order, relaxing the live requirement, is hereby rescinded effective immediately; (b) any credits obtained between March 10, 2020 and the effective date of this Order shall be considered live-credit hours; and (c) the

live requirement is reinstated such that, going forward, courses must comply with the provisions of amended Reg. 103:1(n) to be considered "live" instruction.
